In order to participate in **ATHENS KIDS MART** Seasonal Sale, You, the undersigned (Consignor) and **ATHENS KIDS MART** (the Organizer) agree to the following terms of this contract:

Delonda St. John (Organizer of **ATHENS KIDS MART**) does not anticipate any theft, damage, or loss of any of your consigned goods. However, such an event is possible. Delonda St. John (the Organizer) or any of her associates at **ATHENS KIDS MART** will not be held liable for such events.

You, the Consignor, agrees to participate in the **ATHENS KIDS MART** Seasonal Sale and profit from it if the Consignor's items sell; agrees to waive any and all claims for the loss and/or damage from whatever foreseen or unforeseen cause; and will NOT hold **ATHENS KIDS MART**, Delonda St. John (Organizer of **ATHENS KIDS MART**) and/or her associates responsible for loss or damage to Consignors items.

- <u>CONSIGNMENT FEES</u> The Organizer of ATHENS KIDS MART will deduct a consignment fee of 50% from the proceeds of this Seasonal Sale per Consignors sold items. You, the Consignor, will be paid 50% from the proceeds of your sold items.
- <u>50% OFF SALE</u> All items will be sold for 50% off the black or blue inked price tags on the 50% off sale days. Red inked price tags will not be discounted. Consignor determines all prices. See flier and/or our website www.AthensKidsMart.com for details.
- 3. <u>CHARGE/DUE BILL</u> If the Consignor uses the ATHENS KIDS MART Charge/Due Bill system, the total balance is due by May 25, 2024 or a \$30 fee will be added to the Consignors total amount due and the Consignor will no longer be able to use the Charge/Due Bill system at ATHENS KIDS MART.
- PAYING CHARGES/DUE BILL Consignor is to pay off any Charges/Due Bill by May 25, 2024. Charges cannot exceed \$100.00.
- PAYMENT TO WORKERS & ADVERTISERS (NOT their representatives) will be paid beginning April 18-19, 2024. Please appear in person to collect funds at the address shown below.
- PAYMENT TO CONSIGNORS (NOT their representatives) will be paid beginning April 25-26, 2024. Only the Consignor is to appear in person beginning April 25-26, 2024 to collect funds. Please appear at the address shown below to collect funds from the sale of your sold items. Consignors can check if their items have sold in person only at the store, NOT via phone, email or Facebook inquiry, from April 25-26, 2024.
- 7. <u>CHECKS</u> will be mailed to the Consignor approximately 7-10 days AFTER the end of this Seasonal Sale which ends May 31, 2024. Consignors homemade price tags will not be returned via mail. Proceeds over \$10 will be mailed to the Consignor if not picked up by May 31, 2024. If Consignor does not pick up proceeds and homemade price tags by May 31, 2024 and proceeds are less than \$10, the Consignor agrees to forfeit those proceeds and those funds will be used at our discretion.

- 8. <u>UNCASHED CHECKS</u> All checks not cashed by the Consignor within 10 days of date of issue will be voided.
- PICK UP ITEMS All unsold items you intend to retrieve and not donate to Athens Kids Mart, can be picked up May 26, 2024 during normal business hours. Pick up earnings only by the close of the business day on May 31, 2024. You, the Consignor, must retrieve your own items throughout the store.
- <u>NO PICK UP</u> of items the last week of the sale May 27-31, 2024. You, the Consignor, must retrieve your own items throughout the store if you want to keep them.
- 11. <u>UNSOLD ITEMS</u> Anyone who donates items or leaves unsold Consignor items that are not picked up by you, the Consignor, by the end of the business day on May 31, 2024 will become the property of ATHENS KIDS MART and donated and/or sold at the ATHENS KIDS MART Rummage Sale. No exceptions will be made for any reason or to any person. No phone calls, emails or Facebook replies will be made to the Consignor to remind them of their responsibilities outlined in this contract.
- 12. <u>RUMMAGE SALE</u> Consignors that donate items can shop the \$1.00 Rummage Sale to be determined. The \$1.00 Rummage Sale will be to be determined for the public.
- 13. <u>RESTOCKING</u> Due to limited space, when the Consignors sells 5 pairs of shoes and/or 10 items of clothing, you, the Consignor, may restock with new items. Come to ATHENS KIDS MART in person to the address shown below to check as to which of your items have already sold so you know what to restock. We are unable to check for you via phone or email.
- 14. WHEN TO BRING BIG ITEMS TO SELL Sunday's are the best days to bring in furniture, exercise equipment and any large items. We may be able to assist you but please bring someone to help you with big items. After our posted "Drop Off" days are over - see our website www.AthensKidsMart.com for exact dates - you, the Consignor will be responsible to hang up or display your items yourself in the store. Our time is limited and we cannot always leave the cash register to assist you.
